## Attendance at AGM

### IMPORTANT

Information regarding the Annual General Meeting for 2025 is included in this issue of the Newsletter. There is a **Special General Meeting** preceding the AGM to vote on a proposal to change the Constitution of Harrow u3a. Amongst other matters, **this is to permit meetings to include members on Zoom**; refer to pages 9-11 for more details.

**The business of the SGM and the AGM cannot proceed unless there is a quorum of members present** (defined as 10% of the membership or 100 members, whichever is the lowest). At the time of writing, there are 820 members and a quorum is therefore 82 members).

Although a link via Zoom will be available, **it is imperative that at least 82 members attend in person** at Harrow Arts Centre., so that the SGM Resolution to change the Constitution can be voted upon. A majority of 2/3 of the members present is required to pass the Resolution and **members on Zoom will not be counted in the quorum nor entitled to vote on the Resolution**, as this is not permitted by the current Constitution.

If the Resolution is passed, then members on Zoom will be included in the quorum and will be entitled to vote on matters in the AGM.

### Thursday 9<sup>th</sup> January – John Ashmele – ‘The History & Role of Toastmasters’

Gary’s talk is illustrated with many images (some taken by him), recordings, video extracts and many anecdotes about Adler’s friends and associates such as Chaplin, Duke Ellington, George Gershwin, Billie Holiday, and will include some live performance on the harmonica.

### Thursday 3<sup>rd</sup> April – Lucy Allen, Stunt Woman – ‘Ship of Dreams; Tales from The Titanic’

In 1996 Lucy Allen was one of four British Stunt Women chosen to go to Mexico and work on James Cameron’s film ‘Titanic’ for 10 days. She came back 21 weeks later as a Titanic ‘Survivor’ having got through the difficult shoot and many huge Stunt set pieces in one piece! This talk is about the history of the doomed liner Titanic and what it was like working on the Oscar winning film.

#### **MARCH 16<sup>th</sup> The Wallace Collection**

The Wallace Collection is a national museum which displays the art collections brought together by the first four marquesses of Hertford and Sir Richard Wallace, the son of the 4th Marquess. It was bequeathed to the British nation by Lady Wallace, Sir Richard's widow, in 1897. The Museum was opened to the public in 1900. Among the Collection's treasures are an outstanding array of 18th-century French art, many important 17th and 19th-century paintings, medieval and Renaissance works of art and one of the finest collections of princely arms and armour in Britain. Entrance is free.

Experience one of the hidden treasures in Bushey. Bring a picnic and together enjoy the peaceful ambience of this delightful garden. The garden was opened to the public in 1937. Sadly it became neglected and suffered from vandalism. Thanks to funding from the Heritage Lottery and Big Lottery fund 'Parks for People' programme from Hertsmere Borough Council, the garden received a much needed cash injection to fully restore it to its former glory. It was re-opened in July 2010. Bushey Museum is an 8 minute walk from the gardens and you may wish to pay it a visit. The Museum and Art Gallery has a local history collection plus a major art collection spanning 200 years, with paintings, prints and drawings, sculpture, pottery and historic Church silver.

### Sustainability and Climate Change

A highlight last term was hearing visiting Emeritus Prof Steven Bown from UCL who gave us a wide-ranging lecture on Population, Health, and the Environment. We felt he'd be an excellent speaker for a future Hu3a monthly meeting. We also heard talks on flooding, insurance for sustainable projects, living with "forever" chemicals, and we discussed the latest local regeneration proposals.

This spring term we're looking forward to a visit by John Baxter, the U3A's national subject advisor on climate change & environment, who will tell us about the strengths and weaknesses of the electricity system – generation and distribution – in the context of renewables and zero carbon.

We'll also examine the sustainability of chocolate (free samples?), search out good news stories on the environment, and visit and report on Futurebuild (exhibition and seminars) at ExCel in early March. And we'll keep an eye on local environment matters.

We run our monthly meetings flexibly to accommodate the interests of our members. If you have a concern about climate or the environment, please come along and tell us. ### Photography Group's Summer Projects

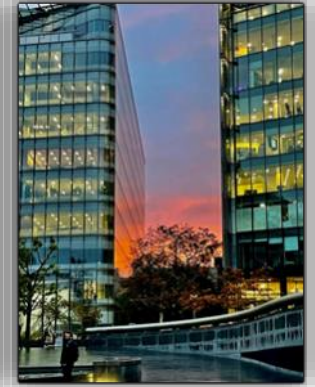

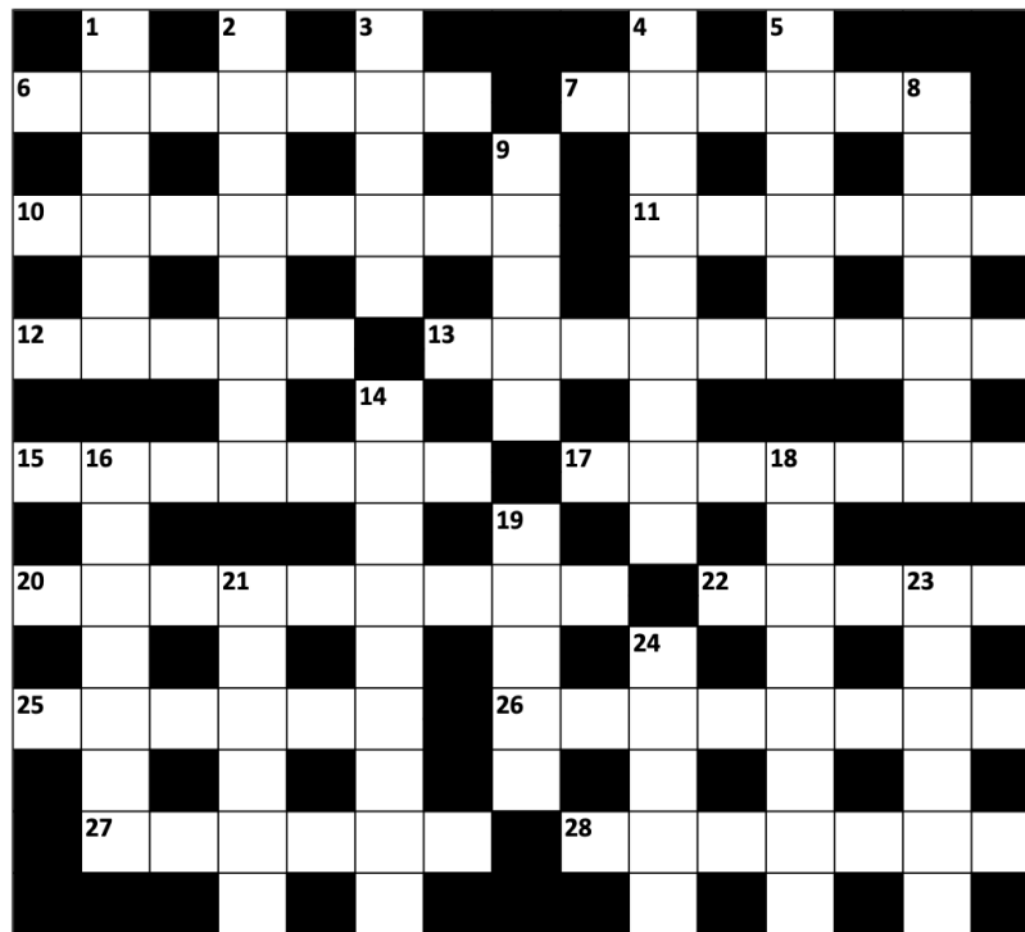

Members attending on Zoom will not be entitled to speak or vote for the Resolution at the Special General Meeting, but provided the Resolution is passed will be able to speak and vote for all items at the Annual General Meeting.**

### STANDING ORDERS

Rule 14 of the Constitution sets out details for the operational procedures at Annual or Special General Meetings of the U3A.

**The notes below clarify items in Rules 14 & 15.**

#### **(a) Business of the meeting:**

In advance of the meeting, the Chairman and Secretary will determine the Agenda and prepare recommendations as to the order in which the business is to be conducted. The Management Committee will confirm agreement and the Agenda will be circulated to members in accordance with the Constitution.

#### **(b) Conduct of meetings**

The conduct of meetings will be the responsibility of the Chairman. The Chairman will have power to lay down time limits for the discussion of items on the Agenda. The Chairman will rule on any question under the standing orders, or on points of order or information. A challenge to a ruling by the Chairman must be moved and formally seconded. The challenger may make one speech in favour of the motion of challenge and the Chairman may make one speech in favour of the ruling. The motion should be put to the vote without further debate. In a vote, such a challenge will require the support of two-thirds of the members present and voting at the meeting, an abstention not being regarded as a vote for this purpose.

#### **(c) Minutes**

Minutes will be kept of all general meetings. The minutes of the previous meeting having already been circulated, the Chairman will call for any questions regarding their accuracy. When there are no further questions the Chairman will declare them (as amended, if necessary) confirmed. Members will then be at liberty to raise points arising out of the minutes, except on matters appearing elsewhere on the agenda.

#### **(d) Voting**

Voting will be by show of hands, unless the Chairman directs otherwise. Tellers will, if required, be appointed at the beginning of the meeting. Decisions will be taken by a simple majority of those **present in person or by electronic means** and voting (an abstention not being regarded as a vote for this purpose), unless otherwise directed by these standing orders or the constitutional rules of the Harrow University of the Third Age.

## Special General Meeting



### Special General Meeting Thursday 13<sup>th</sup> March 2025

#### PROPOSED RESOLUTION TO AMEND CONSTITUTION OF HARROW u3a

1. The Committee wishes to amend the Constitution of Harrow u3a to improve flexibility in the way we arrange and run meetings. The reason for this is that the current constitution only allows in-person meetings and the Charity Commission recently removed the dispensation, introduced during the Covid pandemic, to allow charities in this position to hold electronic meetings. The Third Age Trust has consented to the proposed amendments as required by the Hu3a Constitution.
2. To continue to operate legally, and to improve accessibility and inclusivity for all u3a members, the Committee proposes the following amendments:
  - a) To allow general meetings (Annual or Special) to be held that allow attendance in person or by proxy or by suitable electronic means. The quorum will comprise u3a members present by any of these means.
  - b) To allow online Committee and Sub-committee meetings as well as in-person meetings.
  - c) To formalise procedures to allow urgent decisions to be taken by the Committee between Committee meetings.
  - d) To introduce proxy voting whereby a member may appoint another Hu3a member as proxy to attend a general meeting and vote on his or her behalf. Proxies must be appointed by a signed formal Proxy notice and delivered to the Hon. Secretary 14 days in advance of the meeting.
3. To reduce uncertainty, the Committee also proposes to reduce the grace period for paying annual membership fees from 2 months to 6 weeks after the due date.
4. If approved at the SGM, all amendments – **with the exception of proxy voting** – will be effective for the 2025 AGM. Proxy voting will only be introduced for the 2026 AGM because the amendments to the constitution are not retrospective and proxy voting cannot be initiated prior to the 2025 SGM/AGM.

It is a genuine charity with no highly paid executives and all the money raised goes towards building schools for orphaned and abandoned children and to help women in a male-dominated culture. The parcel of used stamps I sent will probably raise about £15 which would sustain a child in Ethiopia for about a month.

#### IMPORTANT

1. When cutting stamps off envelopes leave a wide margin, at least 1 inch all round, as the stamps are sold by weight
2. Even more important – when posting stamps to Malcolm, stamps tend to bulk up in the middle of the envelope and then do not pass through the slot in the Royal Mail sorting office incurring a £1.50 surcharge. A large stamp only costs 19p extra.
